WSOR STATION	WSOR STATION	49-XXX-XX 48-XXX-XX	\$550.	+\$1.	R-1, R-2

R-1: WSOR (WHEN FROM OR FOR BEYOND)

R-2: WSOR

EXAMPLE: Empty car moving from Point A to Point B with distance of 197 miles.

Non-Hazardous car rate would compute to \$527 (\$330 base rate + \$197 mileage rate) +FSC

Hazardous Residue car rate would compute to \$747 (\$550 base rate + \$197 mileage rate)+ FSC

CONDITIONS:

- 9 STCC LISTED NOT ALL INCLUSIVE AS RATES WILL APPLY TO EMPTY MOVES NOT PRECEDED BY OR FOLLOWED BY LOADED REVENUE MOVE.**
